1. Welcome & Introductions

- a. The meeting was called to order at 10:02 a.m. and members were welcomed.

2. Approval of Previous Meeting Minutes (August 20, 2025)

- a. Members reviewed the August 20 minutes, which were presented in a new bullet-point format. Discussion indicated a preference to continue with this more concise style.

Motion: Mr. Johnnie Phillips made a motion to approve the minutes as presented.

Second: Ms. Anne Key seconded the motion.

Vote: Motion carried unanimously.

3. Old Business

- a. **Resolution 883 Clarification:** Members discussed project coding in Resolution 883. Questions were raised regarding abbreviations such as *TR* (Transit) and *TSMO* (Transportation Systems Management & Operations). Staff clarified definitions and noted these will be added to the project list for reference. Members also discussed urbanized area numbering (e.g., Anniston as #254) and project categorizations.

4. New Business

a. TIP Spreadsheet Updates

- i. Staff reviewed the TIP spreadsheet:
 1. Adjustments made to reflect funding increases approved in August (Friendship Road and Airport Bridge Replacement projects).
 2. Spreadsheet updated for cost inflations and year shifts; bottom line shows deficit in FY 2027. Projects will need to be advanced or rescheduled.
- ii. Administrative modifications included date shifts only; no fiscal year changes. One railroad project noted as non-MPO funded.
- iii. **Discussion:** Clarification requested on right-of-way target dates and utility relocations. Members suggested adding contractor award and completion dates for better tracking. Staff will review feasibility of adding this information in future TIP updates.

b. Resolution 885 – Adoption of 2050 Long Range Transportation Plan (LRTP)

- i. Staff presented the final draft LRTP, developed with consultants Skipper Engineering and Sain Associates. The plan projects transportation needs and fiscally constrained projects for the next 20 years. Five constrained projects were highlighted:
 1. Widen Friendship Road (Choccolocco Drive to Leon Smith Parkway)
 2. Four-lane Bynum-Leatherwood Road (Morrisville Rd. to US-431)
 3. Jacksonville Bypass (US-21 to US-21)
 4. Four-lane Summerall Gate/Bynum area connectors
 5. US-78 widening to MPO boundary
- ii. Visionary (non-constrained) projects were also reviewed. Members discussed urban area labeling, project mapping corrections, and future needs (e.g., SR-77 improvements).
- iii. **Motion:** Mr. Johnny Phillips made a motion to recommend adoption of Resolution 885.
Second: Mr. Tony Ball seconded the motion.
Vote: Motion carried unanimously.

c. Status of Pre-Construction Projects

- i. Staff reported no updates received from ALDOT due to vacant contact positions. Members agreed it is still helpful to note the lack of updates in minutes for the record.

d. Safety Observations

- i. **SR-202 and US-431 Speed Limits:** Members reiterated concerns about inconsistent speed limits (55 to 45 mph) and associated safety issues. Consensus to re-present the request for a speed study, framed as a safety issue (not revenue enforcement). Staff will raise the concern again with ALDOT and local jurisdictions.
- ii. **Intersection of SR-21 and Iron Mountain Road, Bynum Leatherwood Road and SR-202, and Henry Road and US-431:** Members noted lack of lighting

creates safety hazards, particularly in poor weather. Suggested solar or hardwired lighting options. Staff to forward concern.

- iii. **Coleman Road at US-78 (Oxford):** Members noted difficulty for trucks at the tight intersection, especially with the nearby food distribution facility. Suggested intersection improvements may require ROW acquisition and utility relocation.

e. Human Services Coordinated Transportation Plan (HSCTP)

- i. Staff presented the draft HSCTP covering the full East Alabama region. Plan identifies transit needs, barriers, and resources. Public meeting scheduled for **September 23, 2025, 1:00–3:00 p.m., EARPDC Conference Room**. Members may request full copies.

5. Other Business

a. Bylaws and Membership Update

- i. Staff recommended delaying major bylaw revisions until after November, when new municipal leaders take office.
- ii. Discussion of convening a “super-meeting” of MPO, TAC, and CAC members later in the year to improve participation and review responsibilities.
- iii. Membership Subcommittee emphasized reaching out to members falling below attendance thresholds and filling vacant seats.

b. Transit Report

- i. Fixed route/paratransit ridership holding steady.

c. Announcements

Resolution # 886

Amending the Fiscal Year 2026 Unified Planning Work Program (UPWP) Task 1.1 MPO Administration – Inclusion of MySidewalk Subscription

WHEREAS, the Calhoun Area Metropolitan Planning Organization (MPO) is the organization designated by the Governor of the State of Alabama as being responsible, together with the State of Alabama, for implementing the applicable provisions of 23 USC 134 and 135 (as amended by the Fixing America's Surface Transportation [FAST] Act, Sections 1201 and 1202, December 2015); 42 USC 2000d-1, 7401; 23 CFR 450 and 500; 40 CFR 51 and 93; and,

WHEREAS, the US Department of Transportation (USDOT) requires all urbanized areas, as established by the US Bureau of the Census, to conduct area-wide transportation planning, and the designated planning organization to submit a Unified Planning Work Program (UPWP) as a condition for meeting the provisions of Title 23 USC 134; and,

WHEREAS, consistent with the declaration of these provisions, the East Alabama Regional Planning and Development Commission (EARPDC), as staff to the MPO, in cooperation with the Alabama Department of Transportation (ALDOT) Local Transportation Bureau, has prepared a Unified Planning Work Program for Fiscal Year 2026; and,

WHEREAS, pursuant to its duties, functions, and responsibilities, the Calhoun Area MPO proposes to allocate up to \$8,000 from Task 1.1 – MPO Administration to renew the subscription license for the **MySidewalk** data and visualization platform;

NOW, THEREFORE, BE IT RESOLVED that the Calhoun Area Metropolitan Planning Organization hereby amends the Fiscal Year 2026 Unified Planning Work Program (UPWP) as indicated above.

Resolution #887

Adoption and Support of Statewide Performance Measurement Targets: Safety (PM1) and Bridge/Pavement (PM2)

WHEREAS, federal regulations require that the Metropolitan Transportation Plans (MTPs) and Transportation Improvement Programs (TIPs) include System Performance Measurement Targets for urbanized areas; and

WHEREAS, the Calhoun Area Metropolitan Planning Organization (MPO), in coordination with the Federal Highway Administration (FHWA) and the Alabama Department of Transportation (ALDOT), has reviewed the requirement to adopt Performance Measurement Targets for use in the transportation planning and programming process as required by 23 CFR 490.105; and

WHEREAS, the Alabama Department of Transportation has established the following statewide performance targets for Safety (PM1) and Bridge/Pavement (PM2) performance measures, as shown below:
