1. Welcome & Introductions

- a. The meeting was called to order at 10:03 a.m. and members were welcomed.

2. Old Business

a. Approval of Previous Meeting Minutes (August 20, 2025)

- i. Members reviewed the September 17, 2025 minutes.

Motion: Mr. Red Etheredge made a motion to approve the minutes as presented.

Second: Mr. Johnnie Phillips seconded the motion.

Vote: Motion carried unanimously.

3. New Business

a. Election of Officers

- b. The Committee held elections for Chair and Vice Chair. Members commended Mr. Miller for his service and leadership.

A motion was made to retain the current Chair (Mr. Miller) and Vice Chair (Mr. Huddleston).

No additional nominations were received.

Vote: Motion carried unanimously.

c. Review of FY2024–2027 TIP and Administrative Modifications

- i. Staff reported limited administrative modifications this month.
 - 1. A **Level of Effort project** was added to fund elevator improvements at the EARPDC building.
 - 2. A **state project date adjustment** was made; this project is not MPO-funded.
 - 3. The **TIP spreadsheet** was updated to reflect ALDOT’s latest cost data, showing a **negative balance in FY2026**.

d. Resolution 886 – UPWP Amendment (MySidewalk Subscription Renewal)

- i. Staff presented Resolution 886 to reinstate funding authorization for renewal of the MySidewalk subscription (approx. \$8,000). The service supports demographic and project mapping and was used extensively in the Human Services Coordinated Transportation Plan and other MPO products.

Motion: Mr. Burell moved to recommend adoption of Resolution 886.

Second: Mr. League.

Vote: Motion carried unanimously.

e. Resolution 887 – Adoption of 2025 Safety Performance Targets (PM1)

- i. Staff summarized the state’s annual performance targets under PM1 (Safety). The MPO traditionally adopts ALDOT’s statewide targets. Notable changes included:

- 1. Percent of Bridges in Good Condition: $\geq 20\%$
- 2. Number of Serious Injuries: Target reduced to 6,200

- ii. Motion: Mr. League moved to recommend adoption of Resolution 887.
Second: Mr. Burell.

Vote: Motion carried unanimously.

f. Resolution 888 – FY2024–2027 TIP Amendments (Revised)

- i. Staff explained that the TIP amendments were updated the morning of the meeting after rechecking the fiscal constraint. The revised proposal now moves two projects—including Friendship Road Phases I & II—to FY2027 to maintain budgetary balance in FY2026, while moving one project to FY2026 to allow work to be completed in tandem with the earmarked demo project on the same road.
- ii. The change will temporarily relieve deficit pressures for FY2026 but leaves FY2027 in deficit pending further funding adjustments.
- iii. Members discussed potential safety implications of delaying bridge work and the importance of timely project delivery. Staff noted that additional funding or schedule coordination with the City of Oxford would be required to maintain fiscal constraint.
- iv. Motion: Mr. Smart moved to recommend adoption of the revised Resolution 888.

Second: Mr. League.

Vote: Motion carried unanimously.

g. Status of Pre-Construction Projects

- i. Staff provided updates based on ALDOT and local sponsor reports:
 - 1. Friendship Road Phases I–III (Oxford): Awaiting right-of-way authorization; funding agreements in progress.
 - 2. Airport Road Bridge (Oxford): Environmental document approved; ROW submittals pending.
 - 3. Signal Timing (Anniston – SR-21 & SR-202): Implementation completed; final report pending.
- ii. No new construction projects reported this month.

h. Safety Observations

Members reviewed ongoing safety items.

- i. Speed Studies (SR-202 & US-431):

Staff reiterated that ALDOT and local jurisdictions are not pursuing new speed studies at this time due to recent analyses showing no need for change. Discussion followed regarding inconsistent speed limits, enforcement visibility, and safety risks related to abrupt speed reductions. Members expressed concern that citizens’ perspectives were not being fully considered.
- ii. Consensus was reached for members to individually engage County Commissioners and City Council representatives to encourage renewed evaluation of speed and safety conditions.
- iii. Street Lighting:
 - 1. Henry Road @ US-431 Bypass – No further action; initiative tied to former councilmember.
 - 2. Buckner Blvd @ SR-202 – Still under consideration by Oxford.
 - 3. Coleman Rd @ US-78 (Truck Turning Radius) – Oxford was not present at TAC; discussion postponed until next attendance.
- iv. Jacksonville – SR-204 / Nesbitt Lake Road:

Members raised safety concerns over increased traffic from new apartments and JSU student housing. ALDOT has planned future turn lanes, pedestrian improvements, and bridge replacements on SR-204, but no immediate signalization is scheduled. Members emphasized the need for proactive safety measures given the student population.

4. Other Business

a. Membership & Vacancies

The Membership Subcommittee continues reviewing appointments and vacancies:

- i. **Anniston:** 9 seats; 5 vacancies.
- ii. **Oxford:** 9 seats; 4 vacancies.
- iii. **Jacksonville:** 2 vacancies.
- iv. **Weaver:** 3 seats; currently no active representatives.

- v. **Hobson City:** Well represented by Mr. Johnnie Phillips.
- vi. Members commended staff for maintaining updated contact information and consistent meeting notices. Discussion emphasized improving attendance and reengaging appointing authorities to fill vacancies.

b. Upcoming “Super Meeting”

- i. Staff announced plans for a joint MPO/TAC/CAC “Super Meeting” in late 2025 or early 2026 to review projects, clarify roles, and emphasize participation responsibilities—particularly for newly elected officials in Anniston and Jacksonville.

c. Transit Report

- i. Staff reported that fixed-route ridership remains above prior-year averages, while paratransit ridership dipped slightly in Anniston and Jacksonville. Overall system performance remains steady.

d. Announcements

- i. **Next CAC Meeting:** November 19, 2025

- a. There being no further business, the meeting adjourned at 11:15 a.m.
